
#### **GROUP SCOUT LEADER**

I hope that you will agree that the skills our members are learning are setting them up with Skills for Life.




The Group is reliant on many people that support us when they can, either in uniform or with essential skills and I am pleased to say that Karen Hart has returned as a Section Assistant to help when she is needed.

I must also give thanks to Roger Hart, who continues in the background to undertake his role as Quarter Master, looking after all our equipment and carrying out various maintenance activities throughout the year on the buildings.

The Group Committee meets monthly and they along with the Section Leaders organise and run the fundraising for the Group. Without the committee, we would not be able to function as a Group.

Our Young Leaders are Explorer Scouts, who work with the Beaver Scouts and Cub Scouts supporting the Leaders. This helps them to achieve the service section of their awards, but is also a valuable asset to the Leaders, helping with games and badge work throughout the year.

Looking forward into 2018 and beyond, we are in the early stages of replacing our boat shed. Built in 1971, it has been home to the Group and more recently our boats. The time has come to replace it and we are undertaking the ambitious task of building a new boat shed adjacent to the existing Scout HQ, with a sail loft above for meetings, which will allow us to double up on hall use.



#### **SECTION REPORTS**



Our Beaver Scout numbers have remained steady with around twenty throughout the year but with only one girl! We have had 10 Bronze Chief Scout Awards and to gain this the Beaver Scouts had to attain six Challenge Badges plus four activity or staged badges, so we have been very busy.

We had a visit from the Guide Dogs, dental hygienist as well as visits to the Fire Station and Ceramic Experience and an archery night, thanks to Sheila Wicksted and Gordon Prow.

Catriona Hart ran a very successful Beaver/Cub Scout summer camp with a hike, den building, sports and creative activity. We all had fun despite the weather and well done to Catriona for gaining her camp permit. The Beaver Scouts love to be outside as much as possible and building fires to toast marshmallows is a favourite. Our programme caters for everyone with creative nights, learning new skills and learning about safety. The Beaver Scouts who slept over at camp were awarded their Nights Away Badges and they all attained their Outdoor Challenge Badges.

Section nights are greatly helped by a group of Explorer Scouts, who come along every week as part of their Duke of Edinburgh or Chief Scout Platinum award. They have lots of enthusiasm and a great rapport with the Beaver Scouts, helping with games and badge work.

In February, we recognised three Cub Scouts for the achievement of their highest award, the Chief Scout Silver Award. Congratulations to Brodie McCrindle, Ellie Mitchell and Ailsa Rafferty. Gaining the Chief Scout Award is a good indicator that the Pack is healthy and working in line with the Scout Association's award scheme.

# **SCOUTS\***

A rather wet weekend was spent in Douglas Wood in Dundee camping. Here we achieved many of the Scouting basics with fire lighting, cooking and pioneering. The Scouts attended a summer camp at Canty Bay in North Berwick along with the Explorer Scouts, where they took part in a variety of activities including pioneering, hill walking, rafting, and a visit to Fox Lake for a high ropes course over water.

After summer camp, we lost all the older Scouts who moved on to the Explorer Scout Unit. Two of these Scouts achieved their Chief Scout Gold award with another couple only having a few things left to finish off in order to gain this award in Explorer Scouts. This has left the Scout Section with a young membership.

Because of our young membership, we have decided to start from the beginning and run the Section teaching basic Scouting skills. This has included the use of Tilley lamps, navigation, knife and axe skills, fire lighting and first aid. One of the main aims was to get all the Scouts working together as a team, which for a young group they are doing extremely well.

We have awarded the following badges to the majority of the Scouts: Model Maker, Emergency Aid stages 2 and 3, Pioneer. Most of the Scouts are working through their Skills Challenge badge.

A sign that the Troop is running correctly is the awarding of our highest award - the Chief Scout Gold Award. This year, two Scouts achieved this award - Ewan Hope and Gregor Mitchell. Others will complete theirs in the near future within the Explorer Scouts.

The Scouts put a team in for the Gibb Bugle competition, where they came second in a very close run competition, This is a real test of their Scouting skills that they have learnt and for a Sea Scout Troop to gain second place is really good!



We had a camp organised for the beginning of the year but unfortunately, we had to cancel because of the snow. This camp has been rearranged for the middle of April and will allow Derek to gain his camping permit.

We welcome a new Leader, Rebecca who is currently going through her training.

## **EXPLORERS**

2017/18 has been a busy year for the Explorer Scouts. From April, they have been working hard on their Bronze Duke of Edinburgh Award. Most of them have completed two hikes and will do their final one this spring. In addition, the Explorer Scouts have been learning new skills and completing voluntary work.

In July, we all enjoyed a 5-night stay at Canty Bay, North Berwick. We were joined by the Scout Section and did many activities including: Fox Lake high ropes course (over water), the museum of flight and a trip up Berwick Law and down into North Berwick for some fresh fish and chips. While in camp, we enjoyed some sunshine and playing on the beach. By far the best activity of the week in the camp was jumping off rock into the sea below - even Andrew and Sheila had a shot. This camp was enjoyed so much that we have booked to return for a week this year in July.

After the summer holiday, we lost some of our older members when they moved onto College and University; we did however gain a number of Scouts and are now sitting with sixteen regularly attending.

The Explorer Scout program from summer to December was busy fundraising, camping and training for events to come in 2018. In November, the Explorers Scouts took part in a 15-mile night hike from Kinghorn to Limekilns, followed by a busy weekend camp, which included high-rise trampolining and pioneering skills.

In November, five of our Explorer Scouts and one Scout were selected to attend Blair Atholl as part of the Dunfermline District contingent. This included Tegan, Isla, Cameron, Gregor, Ewan and Caelan. They are really excited about this event, which is to be held from 16 - 27 July 2018.

Unexpectedly, five of our Explorer Scouts were invited to go to Japan with our friends from the 83rd Fife (Cairneyhill) Explorer Scouts. Tegan, Cameron, Gregor, Campbell and Ewan will travel to Japan for 3 weeks from 30 July to 18 August.

On arrival in Tokyo, we will stay in a local Japanese Scout Hall and tour Tokyo including travelling on the famous Bullet Train to Osaka. From Osaka, we will travel to Hiroshima on Honshu Island and visit the Hiroshima Peace Memorial Park close to ground zero. Then it is on to the Ishikawa Prefecture for seven days at



the international camp. After the camp, we will travel to lawata for Home Hospitality, where we will stay with Japanese Scouts before returning to Tokyo.

The programme remains varied in accordance with Scout guidelines and included a Burns Supper, Japanese activity evening, and camps. In February, the Explorer Scouts enjoyed a 'ready steady cook' evening, where they were put into teams of 2 with £5 to spend on ingredients and asked to prepare and cook a one course meal and present it to the Leader – the quality of the meals was varied!

The Explorer Scouts are looking forward to all their amazing trips this year as well as an exciting program.

#### STRUCTURE GOVERNANCE AND MANAGEMENT

#### **Governing Document**

The Group operates in terms of the Constitution of the Scout Association, which was incorporated by Royal Charter in 1912, and the Policy, Organisation & Rules ("POR") of the Scout Association as amended by the Scottish Variations.

#### **Appointment of Trustees**

The Group Executive Committee are the charity's trustees. The Group Scout Leader, Assistant Group Scout Leader (if appointed), Group Chair, Group Secretary and Group Treasurer are, *ex-officio*, members of the Executive Committee.

The Section Leaders have the right of membership of the Executive Committee, but are not required to be members.

#### **Organisational Structure**

The Group Scout Council is the electoral body, which supports Scouting in the Scout Group. It is the body to which the Group Executive Committee is accountable. Membership of the Group Scout Council comprises:

- Parents of Beaver Scouts, Cub Scouts, Scouts and Explorer Scouts in the Group;
- Section Leaders, Assistant Leaders and Section Assistants;
- Skills Instructors, Administrators and Advisers, and Patrol Leaders:
- Members of the Group Active Support Unit; any other supporters including former Scouts and their parents, who may be admitted by the Group Scout Leader, the Group Executive Committee or the Group Scout Council:
- The District Commissioner and the District Chair.

The Group Scout Council must hold an Annual General Meeting within six months of the financial year-end to:

- receive and consider the Annual Report and Financial Statements of the Group Executive Committee;
- approve the Group Scout Leader's nomination for the Group Chair and nominated members of the Group Executive Committee:
- elect a Group Secretary, Group Treasurer and certain members of the Group Executive Committee.

The Executive Committee is responsible for the day-to-day management of the Group's affairs and normally meets on a monthly basis.

#### **Risk Assessment**

It is a Scout Association requirement that Health & Safety matters are considered at each Executive Committee meeting and that all Leaders, Assistant Leaders, Executive Committee Members and any other adult helpers must be members of the Protecting Vulnerable Groups ("PVG") Scheme obtained via the Scout Association from Disclosure Scotland within the last five years.

#### **OBJECTS & ACTIVITIES**

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

The method of achieving the aims of the Scout Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership. The Scout Group is responsible for supporting Scouting within Limekilns and the surrounding area.

In furtherance of these objects, the Group continues to run weekly sessions for all Sections during School term time and to organise events, outings and camps throughout the year to encourage the development of our young people.

#### **ACHIEVEMENTS & PERFORMANCE**

It has been another successful year for the Scout Group with all of our members progressing through the Award Scheme, gaining their Bronze, Silver, Gold, and Platinum Chief Scout's Awards as well as numerous Activity Badges.

Congratulations must be given to our Leaders and in particular Liz Milligan who was awarded her Silver Acorn for special distinguished and outstanding service to Scouting.

#### Inclusive

The Group provides an inclusive programme of activities including progression through the various Scouting awards. We link what we do to the four capacities of the Scottish Government's Curriculum for Excellence and try to develop successful learners; confident individuals; effective contributors; and responsible citizens. Where possible we ensure that our members are achieving a number of the experiences and outcomes set by the government. We provide activities for those aged 6-25 in the West Fife Villages area, based in Limekilns, with a current membership of 55 youngsters supported by 10 uniformed Leaders/Helpers.

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- Enjoy what they are doing and have fun
- Take part in activities indoors and outdoors
- · Learn by doing
- · Share in spiritual reflection
- · Take responsibility and make choices
- Undertake new and challenging activities
- Make and live by their Promise.

#### Part of the Community

The Scout Group in Limekilns provides a community facility for the village that is regularly used by local groups, including Dunfermline and West Fife Rotary, Broomhall Curling Club, Limekilns Guides, Brownies, and Rainbows, the Village Gala, and many private hires for parties etc.

The Group continues to organise and run village events, including the fireworks, Santa Sleigh, Christmas Post, Hogmanay party, and the River Festival with the Forth Cruising Club. Scouting in Limekilns is most definitely a part of the community, not apart from the community, and will continue to support the local villages in the future.

#### **FINANCIAL REVIEW**

#### Overview

Fundraising is critical to the sustainability of the Group and provides a focus for social activities for members and opportunities for wider community involvement.

Our principal sources of income continue to be membership subscriptions, contributions to the cost of Group activities and fundraising, whereas expenditure primarily relates to Group activities and the running costs of the Scout Hall. The following table provides a summary of our receipts and payments for the year,

#### **Donated Facilities & Services**

Scouting is very dependent on the Leaders, parents and other volunteers without whom the Scout programme could not be delivered. The trustees would like to place on record their thanks to all who have helped to make the Group a success in the past year.

#### **Reserves Policy**

The trustees consider that around three to four months expenditure is an appropriate level of reserves in order to cover the timing differences between receipts and payments and to allow for any unexpected items of expenditure. Reserves at the year-end were £16,162 (2017: £17,264). While this is above the target range, significant funds will be required for improvements to the Scout Hall and for the replacement of the Boat Shed in the next 12 to 18 months.

#### **FUTURE PLANS**

We continue to be committed to providing an exciting programme of activities for 6-25 year olds in West Fife and, as the only Sea Scout Group in Fife, opening up the sailing activities to a much wider audience. To enable us to achieve this, the 46-year-old wooden boatshed needs to be replaced with facilities fit for the 21<sup>st</sup> century. We have started the process with planning applications having been submitted and a small subcommittee of parents formed to raise the required funds, around £400,000, which we aim to raise over the next two years.

## Independent Examiner's Report to the Trustees of 81<sup>st</sup> Fife (1<sup>st</sup> Broomhall) Sea Scout Group

I report on the accounts of the charity for the year ended 31 March 2018 that are set out on pages 14 to 18.

### Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). #### NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 MARCH 2018

#### 1. **Basis of Preparation**

These accounts have been prepared on the receipts & payments basis in accordance with:

- The Charities and Trustee Investment (Scotland) Act 2005 (a)
- The Charities Accounts (Scotland) Regulations 2006 (as amended) (b)

There have been no changes to the basis of preparation or to the previous year's accounts.

#### 2. **Fund Accounting**

- Unrestricted funds are those that can be expended at the discretion of the trustees in the furtherance of the objects of the charity
- Restricted funds are those that may only be used by specific purposes. Restrictions arise when (b) specified by the donor, or when funds are raised for specific purposes.
- The purposes of the funds are shown in Note 13. (c)

#### 3. **Taxation**

- The charity is not liable to corporation tax or capital gains tax on its charitable activities. (a)
- (b) The charity is not registered for VAT, thus all costs are shown inclusive of VAT charged.

#### 4. **Trustee remuneration**

No remuneration was paid to the trustees during the year or in the previous year.

#### 5. **Trustee expenses**

No expenses were reimbursed to the trustees during the year or in the previous year.

#### 6. Transactions with related parties
